Presentations

Superintendent Styburski introduced Roberto Espino-Perez to the Park Board as a member of the Parks department. Roberto received a promotion from part-time to full-time.

Director McCann introduced Rocco Giase and Martha Houston to the Park Board as the newest employees of the Recreation department.

Financial Reports

Commissioners reviewed the August 2021 Payroll and Bills/Check Register and the August 2021 Revenue and Expense Reports.

Commissioner Ludwig moved to approve payment of the August 2021 accounts payable and payroll in the amount of \$917,340.78. Accounts payable checks #106013-#106109, excluding check voids #106033 and prior month check voids #105961 in the amount of \$487,242.00; payroll checks #76905-#76921, #76923 #76925-#76940, and #76942 in the amount of \$13,818.25; direct deposit checks #76922, #76924, and #76941 in the amount of \$249,765.99; deduction checks #111060D-#111065D, #111067D-#111068D, and #111285D-#111295D in the amount of \$166,514.54. Commissioner Fugiel seconded the motion. On a roll call, five ayes (Fugiel, Kuderna, Lemar, Ludwig, Ware). Motion carried.

Staff Reports

Commissioners briefly reviewed the Director of Finance's Monthly Report. Director Chiappetta informed the Park Board that the District received 97.6% of tax levy. Director Chiappetta said the financial forecast is updated through to December.

Commissioners briefly reviewed the Superintendent of Parks' Monthly Report. Superintendent Styburski discussed that the Spray Park and Splash Pad will be closing for the season on October 1, and the pool at Paradise Bay Water Park is currently being painted.

Commissioners briefly reviewed the Director of Recreation's Monthly Report. Director McCann updated the Park Board that Touch a Truck had an estimated 1,700 patrons in attendance and TLC had 90 individuals at that event; and Fall Fest is hosting the annual Food Drive. Director McCann reported on behalf of Executive Director Friedrichs' report; that the Four Seasons OSLAD project is currently in the seeding and blanket of the soccer field phase of the project. Lastly, Director McCann informed the Park Board on a recent Steering Committee Meeting discussing the extension of the East Branch DuPage River Trail, potentially going through Lombard Golf Course.

Commissioners briefly reviewed the Superintendent of Golf Operation's Monthly Report. Superintendent Ingram updated the Park Board on current golf rounds being over 22,000.

Commissioner Fugiel moved to approve change order #3 to add an additional pickleball court at a cost not to exceed \$33,296, as presented. Commissioner Kuderna seconded the motion. On a roll call, five ayes (Fugiel, Kuderna, Lemar, Ludwig, Ware).

Vice President Lemar commended staff on a great job at Touch a Truck.
