## **Financial Reports**

Commissioners reviewed the July 2023 Payroll and Bills/Check Register and the July 2023 Revenue and Expense Reports.

Commissioner Ludwig moved to approve payment of the July 2023 accounts payable and payroll in the amount of \$1,172,599.82. Accounts payable checks #107945-#107994, #107998-#108050, and reissued checks #107995-#107997 in the amount of \$526,857.65; payroll checks #77890-#77924, reissued check #77927, and #77928-#77960 in the amount of \$21,489.64; direct deposit checks #77926 and #77961 in the amount of \$404,404.30; deduction checks #121279D-#121284D, #121654D-#121665D, and #77962 in the amount of \$219,848.23. Commissioner Wolsztyniak seconded the motion. On a roll call, five ayes (Kuderna, Ludwig, Scalzo, Wolsztyniak, Zook). Motion carried.

## **Staff Reports**

Commissioners briefly reviewed the Director of Finance's Monthly Report. Director Chiappetta updated the Park Board on the District receiving the first payment for the Four Seasons OSLAD Phase II Grant, the second payment of the Four Seasons OSLAD Phase I Grant, and the first payment of the Southland OSLAD Grant. Director Chiappetta also, announced she received four submissions for the financial RFP from; BS&A, Tyler, Springbrook, and Oracle.

Commissioners briefly reviewed the Superintendent of Parks' Monthly Report. Superintendent Styburski told the Park Board, Madison Meadow south playground is still awaiting the replacement slide.

Commissioners briefly reviewed the Director of Recreation's Monthly Report. Director McCann discussed the transition from summer programming to fall programming. MMAC memberships and open gym attendance are increasing; PBWP is offering extended operational dates; summer camp ended on a Friday, and Club Rec began that following Wednesday; there are over 700 children signed up for fall soccer; and preschool summer camp ended, and staff is preparing for the preschool school year to begin.

Commissioners briefly reviewed the Superintendent of Golf Operation's Monthly Report. Superintendent Ingram discussed the heat is causing tee time cancellations, but he is providing water and cold rags for golfers.

Commissioners briefly reviewed the Executive Director's Monthly Report. Executive Director Friedrichs thanked Commissioner Kuderna for running tonight's meeting. Executive Director Friedrichs updated the Park Board on the Phase II OSLAD grant at Four Seasons; the playground and walking path are being installed, the shelter has been installed, and the project should be completed by Thanksgiving. Lastly, Executive Director Friedrichs discussed that the Four Seasons soccer fields will be played on for the first time that weekend.
