The Lombard Park District reserves the right to end rentals early if patrons are not following the facility rules.

The Lombard Park District reserves the right to cancel/close due to mechanical failure or inclement weather (Temp under 65/Thunder/Lightning).

The above rental date is not guaranteed until reviewed and accepted by the Facilities and Aquatics Manager and the deposit has been paid.
